



Dayforce Wallet Rewards

Terms of Use – US

This Dayforce Wallet Rewards Terms of Use is an agreement between you and Ceridian HCM, Inc. ("Ceridian"). Ceridian uses the DOSH Holdings, Inc. ("DOSH,") cash-back platform to manage the Dayforce Wallet Rewards program (the "Program"). DOSH is a third party that is not affiliated with Central Bank of Kansas City or Ceridian. By participating in the Program, you agree that DOSH may create a rewards ledger for you using anonymized data as described in the [Dayforce Wallet Mobile App Privacy Statement](#) on its platform in order for you to earn and redeem rewards based on qualifying transactions with participating merchants (the "Services"). These Dayforce Wallet Rewards Terms of Use (the "Rewards Terms") govern your use of the Program.

Your Acceptance of These Dayforce Wallet Rewards Terms

By accessing or using the Services in any way (or any agreement that has incorporated these Rewards Terms) when that option is made available to you, you agree to be bound by these Rewards Terms. You also agree to be bound by the [Dayforce Wallet Mobile App Privacy Statement](#) which governs how we will collect, use, and share your personal information.

You may opt-out of the Dayforce Wallet Rewards program at any time either in the Dayforce Wallet App or by calling customer service at 1-877-723-7434.

Please note, we may, without prior notice or liability to you, discontinue the Services or modify the Services for any reason or may add or remove, even though such changes may affect rewards pending payment to you.

The Services

The purpose of the Services is to reward you for certain qualifying purchases and, if applicable, other activities. DOSH is not affiliated with the merchants that extend offers to you through the Program. Subject to these Rewards Terms, we will automatically provide rewards to you when you purchase qualifying goods or services at participating merchants with your Dayforce Prepaid Mastercard® ("Dayforce Card"). DOSH, in its sole discretion, establishes the terms and conditions for each qualifying purchase or action and determines whether you have satisfied such terms and conditions to receive the associated rewards. The following transaction types are never eligible to receive rewards:

- ATM transactions;

- In-store cash withdrawals or cash back;
- Any transactions identified by a merchant as not being eligible to receive rewards;

All offers made available to you are temporary and may become unavailable without notice.

Without limiting any of the other terms of these Rewards Terms, if you return, charge back, cancel, dispute, or otherwise request a refund for a qualifying purchase for which you have already received rewards, or in the case of fraudulent use of your Dayforce Card in connection with the Card Program, we reserve the right to remove any rewards from your Dayforce Card account or withhold future rewards to offset any such amount, as applicable.

Any rewards that you earn will be transferred to your Dayforce Card account once the eligible transaction data has settled at the merchant. We aim to deliver rewards to the Dayforce Card account within 14 days of settlement, but do not guarantee a specific timeline for payment. You are solely responsible for verifying the accuracy and completeness of any rewards transferred to your Dayforce Card account. All rewards received are exclusive of any applicable withholding, sales, use, excise, value added, or other taxes. You acknowledge and agree that you are responsible for determining, paying, withholding, filing, and reporting all taxes, duties, and other governmental assessments associated with your activity in connection with the Services. Ceridian and DOSH are not responsible for determining whether you owe taxes in connection with your access to or use of the Services or for collecting, reporting, or remitting taxes arising from your access to or use of the Services, except for our own income taxes.

In addition to your other representations and warranties in these Rewards Terms, you represent and warrant that you will not access or use the Services to engage in any illegal, fraudulent, or other illicit activity.

Ownership and Proprietary Rights in the Services

You acknowledge and agree that the Services are protected by applicable copyright, patent, trademark, and other intellectual property laws. All words and logos displayed in connection with the Services that are marked by the [™] or [®] symbols are trademarks and service marks of Ceridian or DOSH and/or their respective owners. The display of a third-party trademark in connection with the Services does not mean that we have any relationship with that third party or that such third party endorses the Services, Ceridian, or DOSH.

These Rewards Terms constitute the entire agreement between you and Ceridian regarding the Services. These Rewards Terms may not be modified, supplemented, qualified, or interpreted by any trade usage or prior course of dealing not expressly made a part of these Rewards Terms. We may also revise these Rewards Terms from time to time in our sole discretion, subject to applicable law. When we revise these Rewards Terms, we will update this document to reflect those changes. You are free to decide whether or not to accept a revised version of these Rewards Terms. If you do not agree to these Rewards Terms or any revised version of these Rewards Terms, you can opt-out of the program at any time either in the Dayforce Wallet app or by calling customer service at 1-877-723-7434. Except as otherwise expressly stated by us, your access to and use of the Services are subject to the version of these Rewards Terms in effect at the time of your access or use.

These Rewards Terms and any rights hereunder may not be transferred or assigned by you without our prior written consent but may be assigned by us without restriction and without your prior consent. Any attempted transfer or assignment by you without our prior written consent will be null and void. No agency, joint venture, partnership, trust, or employment relationship is created between you and us by way of these Rewards Terms.
